Interested bidders having valid GST registration may participate in the auction either personally or through their authorized representative, subject to the following terms and conditions:

Terms & Conditions

1. The material shall be sold on "**As Is Where Is Basis**" and "**Whatever There Is Basis.**"
2. The bidder must possess a valid GST Registration and PAN. Copies of these documents shall be submitted at the time of registration. Registration shall remain open up to 11:30 AM only. No registration shall be entertained thereafter. The auction shall commence at 12:00 Noon sharp.
3. Every bidder shall deposit an Earnest Money Deposit (EMD) of ₹5,000/- (Rupees Five Thousand only) in the form of a Demand Draft issued by any nationalized bank in favour of Director-cum-Principal, Jawaharlal Nehru Government Engineering College, Sundernagar, District Mandi (H.P.)-175018. Bidders failing to deposit the EMD shall not be permitted to participate in the auction.
4. The material to be auctioned may be inspected on any working day before the auction between 10:00 AM and 4:00 PM in the institute premises.

5. The reserve price shall be announced by the Auction Committee at the time of the auction, and bidding shall commence from the reserve price. No bid below the reserve price shall be accepted.
6. The bidder quoting the highest bid shall be declared the successful bidder. The successful bidder shall deposit the full bid amount immediately after the conclusion of the auction and shall lift the material within two (02) days from the date of auction. The material shall be handed over only after receipt of the full payment.
7. The successful bidder, being a GST-registered entity, shall be solely responsible for discharging the applicable GST liability under the Reverse Charge Mechanism (RCM), wherever applicable. The institution shall issue a receipt only for the final auction value without charging GST. The successful bidder shall issue a self-invoice and payment voucher as required under the GST provisions.
8. The successful bidder shall furnish an undertaking to shred the used answer sheets within 15 days from the date of acceptance of the auction.
9. Tax Collected at Source (TCS), wherever applicable, shall be collected from the successful bidder.
10. It shall be the sole responsibility of the successful bidder to lift the auctioned material within the stipulated period of two (02) days. Failure to do so shall result in forfeiture of the EMD, and the bidder shall forfeit all rights over the auctioned material. The institution may conduct a fresh auction and may debar such bidder from participating in future auctions.
11. The EMD of unsuccessful bidders shall be refunded on the same day after the successful bidder deposits the full bid amount. The EMD of the successful bidder shall be refunded only after submission of shredding certificate.
12. Material once sold shall not be taken back under any circumstances.
13. The bid shall be evaluated on a consolidated basis and not item-wise.
14. In the event of any dispute arising out of the auction process, the decision of the undersigned or his authorized representative shall be final and binding on all bidders.
15. The undersigned reserves the right to accept or reject any or all bids without assigning any reason.
16. The undersigned also reserves the right to withdraw or cancel the auction process at any stage without assigning any reason.
17. Any additional terms and conditions, if required, may be announced at the time of the auction.
