### **Public Auction Notice**

It is for the information of General Public that unserviceable items lying in store i.e. Machinery, Tools and Equipment & Scrap of various branches of Jawaharlal Nehru Govt. Engineering College, Sundernagar, Distt. Mandi (H.P.) will be auctioned on **02-02-2026 at 11:00 AM** in the premises of "**Jawaharlal Nehru Govt. Engineering College, Sundernagar, Distt. Mandi (H.P.)**". Therefore, interested GST registered bidders may participate in auction process or may depute their representative to participate in this auction as per the schedule mentioned above. Following are the terms and conditions of the Public Auction:

#### **Terms & Conditions:**

1. The successful bidder has to take up the material on "**AS IS WHERE IS BASIS**" and "**WHATEVER THERE IS BASIS**".
2. The bidder must have valid GST registration and PAN. Documents must be submitted at the time of registration. Registration of firms will be up to 11:30 AM. After 11:30 no more registration will be taken up. Auction will start sharp at 12:00 noon.
3. The bidder will have to deposit security amount of Rs. 10,000/- (Rupees Ten Thousand only/-) as Earnest Money in order to participate in auction failing which they will not be allowed to participate. The EMD shall be attached in the form of DD from any nationalized bank in favour of Director-cum-Principal, Jawaharlal Nehru Govt. Engineering College Sundernagar, Distt. Mandi (H.P.)-175018.
4. The unserviceable store items can be seen in the premises of the institute in any working days between 10:00 AM to 05:00 PM before the auction done.
5. The reserve price for the bid will be announced at the time of bid by the committee and auction will start from the reserve price. The rate quoted shall not be less than the reserve price in any case.
6. The bidder who will give higher bid price will be accepted. The highest/successful bidders will have to deposit the full amount of his bid immediately after the auction is over and will have to lift the material from the site within 02 days of auction. The goods/scrap shall be handed over to the successful bidder only after receiving the balance payment.
7. The successfully bidders (Recipient) being GST entity shall be solely responsible for discharging the applicable GST liabilities directly to Govt. The institution shall only issue receipt reflecting the final auction price only without charging GST. The recipient must issue a self-invoice and payment voucher as per GST reverse charge mechanism (RCM).



8. TCS as applicable will be charged from the successful bidder.
9. It will be the sole responsibility of the successful bidder to lift the goods/scrap within stipulated time. In case, the selected/successful bidder does not lift the goods/scrap within stipulated time i.e. within 02 days of auction, the EMD shall be forfeited and bidder will have no right on goods under Auction. Thereafter, fresh Auction will be initiated and such bidder may be barred from further bidding process.
10. The EMD of the unsuccessful bidders will be released on same day, only after submission of quoted amount by the successful bidder, while, EMD of the successful bidder will be released within one week of completion of auction process.
11. No items once disposed to the successful bidder, shall be taken back in any conditions whatsoever.
12. Bid will be evaluated on consolidated basis not items wise.
13. In case of any dispute with regard to auction, the decision of the undersigned or his representative working in auction process would be final and binding on the bidders.
14. The undersigned reserves the right to accept or reject any of the bid/bids without assigning any reason.
15. The undersigned reserves the right to withdraw/cancel this auction process at any stage without assigning reasons.
