 failing which tender/bid will not be considered. The envelope must superscribed on the top as
 "Tender for Mural".
- 2. The main cover <u>Sealed Envelope</u> (superscribed on the envelope as "Tender for Mural" should contain two sealed envelopes:
 - (i) Technical Bid Envelope,
 - (ii) Financial Bid Envelope.

3. Technical Bid Envelope should contain the following documents:

4. Financial Bid Envelope should contain the following document:

- (i) Rate quoted/offered on prescribed format (Annexure-B).
- 5. Both the envelopes i.e. Technical Bid Envelope and Financial Bid Envelope should be superscribed as "Technical Bid" and "Financial Bid" respectively.
- 6. Both the envelopes i.e. "Technical Bid Envelope" and "Financial Bid Envelope" should be sealed properly and placed in the **main cover** <u>Sealed Envelope</u> as mentioned at point 2 above.
- 7. The single offer without complete documents mentioned above will be rejected and no correspondence in this regard will be sent to the bidder.
- 8. The rate for the works is to be quoted as per the attached format given at Annexure-B.
- 9. The content of the work is mentioned at Annexure-B. However, the final design to be executed will be decided in consultation with the authorities of this institute.
- 10. The said work will have to be completed within a period of four months from the date of issuance of work/supply order. The work will be treated as completed only after the receipt of completion report from the designated committee of this institute.
- 11. The successful tenderer, whose tender is accepted as final, shall have to give an undertaking that the work assigned shall be completed in a professional manner complying with the technical specifications as fixed by this office and the work be completed within the stipulated time.
- 12. The tenderer/bidder shall have to make his/her own necessary arrangements for the items/materials etc. required for the erection/installation of mural/sculpture to the specified place of destination within institute. Any transportation involved to such place of destination at J.N. Govt. Engg. College, Sundernagar, Distt. Mandi (H.P.) shall be arranged by the tenderer/bidder and the related cost shall be included in the price quoted. Successful bidder shall be entirely responsible for payment of all type of taxes, duties, license fees, octroi, road permits, etc., incurred.
- 13. The EMD of the successful tenderer shall remain with the institute till the completion of work/receiving of satisfactory performance certificate from the designated committee of the institute. Any breach in terms and conditions of this document or work/supply order by the successful bidder may lead to penalty from EMD submitted.
- 14. No advance payment will be made. The payment shall be released only after the receipt of completion report from the designated committee of the institute.

- 15. If the successful tenderer/bidder fails, neglects, declines or otherwise does not execute the same in time and in accordance with the terms of the work/supply order, the EMD money shall be forfeited and the Director-cum-Principal of this institute shall be at liberty to complete the assigned work from any other party and any excess cost so incurred over the contract price shall be recoverable from the bills payable to the successful tenderer.
- 16. Tenders will be opened in the presence of bidders or their representatives, who choose to attend on the specified date and time. Bids not having the relevant documents as listed above will be rejected out rightly. It will be presumed that such bidders have just quoted the rates and are not in position to execute the work required. No intimation in this regard will be sent to the bidders.
- 17. In the event of the date specified for bid receipt and opening being declared as a closed holiday, the due date for submission of bids and opening of bids will be the following working day at the appointed times.
- 18. The conditional tenders/ incomplete tender/ tender without earnest money/without tender cost or tenders received after due date/time will be summarily rejected.
- 19. The earnest money deposit will be refunded to the unsuccessful bidders after 7 days of the award of tender/work. No interest will be paid on earnest money remaining with the institute.
- 20. A prospective bidder requiring any clarification of the bidding documents may notify the purchaser in writing or by telex or email or fax at the purchaser mailing address indicated in the Invitation for Bids. The purchaser will respond in writing to any request for clarification of the bidding documents which it receives not later than 7 days prior to the dead line for submission of tenders prescribed by the purchaser. Written copies of the purchaser's response (including an explanation of query but without identifying the source of inquiry) will be sent to all prospective bidders which have received the bidding documents by main office of J.N. Govt. Engg. College Sundernagar or by post.
- 21. At any time prior to the deadline for submission of bids, the purchaser may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the bidding documents by amendment. All prospective bidders who have received the bidding documents will be notified of the amendment in writing or by telex or by fax or by email, and will be binding on them. In order to allow prospective bidders reasonable time in which to take the amendment into account in preparing their bids, the purchaser, at its discretion, may extend the deadline for the submission of bids. No bid/ tender shall be modified subsequent to the deadline for submission of tender.
- 22. The Director-cum-Principal, reserves the right to cancel the tender without assigning the reason thereof. In any case, decision taken by the Director-cum-Principal of this institute will be treated as final.
- 23. Any legal dispute will be settled within the jurisdiction of Sundernagar District Mandi, Himachal Pradesh.
